This letter responds to your Freedom of Information Act (FOIA) request of March 23, 2018, in which you seek the following:

1. Regarding Field Carrier Landing Practice (FCLP) events conducted by EA-18G aircraft stationed at NAS Whidbey Island; does one "landing" mean one completed FCLP circuit and hence two operations or does one "landing" mean one operation?
2. Request additional records for a tabulation of the number of Field Carrier Landing Practice (FCLP) events conducted by EA-18G aircraft at airfields other than Ault Field or at Outlying Field Coupeville for the entirety of calendar year (CY) 2017.
3. Number of EA-18G FCLP landings logged at airfields other than NASWI (Ault Field and OLF Coupeville) for CY 2015, 2016 and 2017, and the names of those other airfields.

Your request was assigned local tracking number 2018-31538-013 and forwarded to Commander, Electronic Attack Wing, United States Pacific Fleet for review and response.

Pursuant to procedures established in Secretary of the Navy Instruction (SECNAVINST) 5720.42F, our search for responsive records encompasses only those records in existence as of March 23, 2018.

Aircrew do not log "operations," they only log landings. In regard to this, the requestor asked for clarification: "Does one "landing" mean one completed FCLP circuit and hence two operations or does one "landing" mean one operation?" Each of the landings listed describes the FCLP approach and landing logged. So, if there are 8 approaches and landing during the flight, 8 FCLP type landings are logged.
